GENERAL TERMS & CONDITIONS

1. The title for this competition is “Win two tickets to Winter Woodland Lights”
 2. The competition is open to UK residents only (excluding residents of the Channel Islands and Isle of Man). Employees of Hampshire County Council and Hawk Conservancy Trust as well as their immediate families are not eligible to enter the competition. Entrants must be over the age of 18 to enter.
 3. Entrants must provide their name and email address if selected at random as the winner. They must agree to the general terms and conditions and privacy policy.
 4. Visit Hampshire will only ever use personal details for the purposes of administering the competition. Visit Hampshire will only keep your personal details for as long as is necessary to fulfil these purposes. Visit Hampshire will not pass on your personal information to a third party without your prior permission. Visit Hampshire abide by the General Data Protection Regulation of 2018 and complies with its provisions to ensure that any data you provide is treated accordingly.
- The competition closes at 23:59 on 15 December 2024. Entries received after this date will not be considered. The prize consists of:
- Two adult tickets to Winter Woodland Lights at the Hawk Conservancy Trust.
- The prize stated cannot be deferred or transferred. There will be no cash alternatives.
5. One competition entry per person.
 6. The judges' decisions will be final and no correspondence can be entered into.
 7. Visit Hampshire reserves the right to cancel this competition or alter any of the rules at any stage, if deemed necessary in its opinion, and if circumstances arise outside of its control.
 8. The prize excludes: any form of insurance, any accommodation, travel to and from the attractions/experiences, any personal expenses and spending money, any additional events or experiences, or items from the gift shops.

9. There is no cash alternative for the prize and it is non-transferable.

10. The winner will be selected at random on Monday 16 December 2024. If the winner is unable to be contacted after reasonable attempts have been made, Visit Hampshire reserves the right to either offer the prize to a runner up, or to re-offer the prize in any future competition.

11. These rules are governed by the laws of England and Wales. This competition is administered by Visit Hampshire (Hampshire County Council)

10. By entering, entrants will be deemed to have agreed to be bound by these rules and Visit Hampshire reserves the right to exclude any entry from the competition at any time and in its absolute discretion if Visit Hampshire has reason to believe that an entrant has breached these rules.

11. The winners' details will be shared with the Hawk Conservancy Trust. By entering the competition, the participants agree that their name may be released on social media. Your email address will NOT be shared with any other party. Entry to the competition is free. An eligible entrant must be an individual and agree to abide by these terms and conditions.

12. Winter woodland lights tickets are for two adults. Those visiting for the event will need to be pre-booked with names. The winner will be given selected dates to choose from to use their tickets.

13. In the event of unforeseen circumstances, the Hawk Conservancy Trust reserves the right to offer alternative prizes of equal or greater value.

14. No responsibility will be accepted by the Hawk Conservancy Trust for loss of entries through technical fault, transmission delays or incomplete, illegible or other damaged entries.

15. Experiences, courses, workshops and events will take place during all weathers unless it is deemed unsafe to proceed by the Hawk Conservancy Trust. If an experience, course, workshop or event is cancelled by the Hawk Conservancy Trust due to safety issues or because of low numbers, you will be offered an alternative date; if there is no alternative date, the value of your ticket can be exchanged for a different activity provided by the Trust. We will endeavour to contact all the guests on any activity that we cancel. However, for larger events as well as our general admissions, a message may be posted on the Trust's Facebook page and/or the Trust's website, and we advise monitoring these prior to attending any activity.

16. Vouchers and tickets are non-refundable and cannot be resold. Once a specific date is booked, they are non-transferable.

17. The Trust reserves the right to vary the content and format of any event, experience, course or workshop, without notice, if necessary.
